Inboard Rudder Stock Sealing unit for new construction or replacement on pleasure and commerical craft.

Description:

A watertight, self aligning seal, precision machined from UHMW. It is a one piece, water-lubricated housing for a nitrile lip seal.

Rating:

For Rudder stock sizes of 3/4" - 3 1/2" or 20 mm - 89 mm at water temperatures from 32°F to 90°F.

Service Restriction:

Unit Certification is not required for this product. If the manufacturer or purchaser request an ABS Certificate for compliance with a specification or standard, the specification or standard, including inspection standards and tolerances, must be clearly defined.

Comments:

- 1) The Manufacturer has provided a declaration about the control of, or the lack of Asbestos in this product.
- 2) The hose material and that of the lip seal is to be suitable for the intended service. The burst pressure of the hose is not to be less than four times the design working pressure. In general, the hose may be installed in a system provided it is visible at all times, easily accessible, and confined to one watertight compartment in conjunction with the provisions of 4-4-1/9.19 of the ABS Guide for Building and Classing Yachts.
- 3) The equipment should be visually inspected by the attending Surveyor during periodic surveys, with particular attention being given to the flexible hose assemblies and nitrile lip seals. These are to be replaced if deemed necessary.
- 4) The manufacturer's recommended installation procedures are to be followed.
- 5) In rudder trunks which are open to the sea, the seal is to be fitted above the deepest load waterline.
